

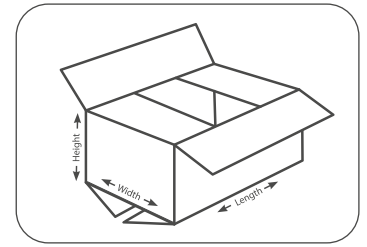

## General Terms & Conditions 2024

### Rates terms and conditions

- ✦ The general terms and [Logistics Services Conditions \(LSC\)](#) apply to all shipments.
- ✦ Rates and surcharge do not include the variable [fuel surcharge](#).
- ✦ If applicable, we will charge a minimum price per package.
- ✦ Volume ratio Economy:  $L * W * H / 4000$
- ✦ Volume ratio Express:  $L * W * H / 5000$
- ✦ Maximum standard length is 270 cm.
- ✦ Maximum package size  $(2 \times \text{width}) + (2 \times \text{height}) + (1 \times \text{length})$ : 400 cm. Other sizes are on request.
- ✦ Rates do not include any (mandatory) customs documentation (ATR, T1).
- ✦ The specified transit times are indicative and may vary.
- ✦ Shipments will be presented twice before transferred to a local collection point or depot.
- ✦ Pallet shipments are redirected through another service, pallet rates on request.
- ✦ Seabourne Logistics will act as forwarder and outsource the transport to 3<sup>rd</sup> parties.
- ✦ Rates are valid until 31-12-2024. Seabourne Logistics can adjust rates, terms and conditions at any given time.

  - For all packages with a longer length than 100 cm or a 2<sup>nd</sup> longest length than 76 cm.
- ✦ Manual bookings: € 4,95
  - Bookings not made via our online booking system.
- ✦ Pick-up: € 20,95
  - Pickup at a different address other than the primary billing address.
- ✦ Deliveries at a residential address. € 3,95
- ✦ [Non-Conveyable](#). € 7,95
- ✦ Address correction. € 23,95
- ✦ For return shipments, a surcharge of 20% applies to your export rate.
- ✦ Unsuccessful pick-ups. € 19,95

  - The premium amounts to 1% of the value of the shipment with a minimum charge of € 35,00.
